18 Dec 2008	17 Jun 2010	1. She must notify the GMC promptly of any post she accepts for which registration with the GMC is required and provide the GMC with the contact details of her employer;
		2. At any time that she is employed, or providing medical services, which require her to be registered with the GMC, she must place herself and remain under the supervision of an independent remedial/workplace supervisor nominated by her employer, or contracting body, and approved by the GMC;
		3. In the event that she is working as a sole practitioner, she must obtain an independent remedial/ workplace supervisor (who is not a personal friend), approved by the GMC;
		4. She must not work as a locum or undertake any out-of-hours work or on-call duties;
		5. She must work with her remedial/workplace supervisor to formulate a Personal Development Plan (PDP) specifically designed to address deficiencies in the following areas of her practice, * Communication skills, * Conflict resolution, * Anger management, * Working in a team, * Any other deficiencies identified by her remedial/workplace supervisor(s), or as a result of the GMC's Performance Assessment;
		6. She must forward a copy of her PDP to the GMC within three months of the date on which these conditions come into effect;
		7. She must meet regularly with her remedial/workplace supervisor to discuss her progress towards achieving the aims set out in her PDP, with a frequency to be determined by him/her;
		8. She must allow the GMC to exchange information about the standard of her professional performance and her progress towards achieving the aims set out in her PDP with any other person involved in her retraining and supervision;
		9. She must undergo an assessment of her professional performance prior to a review hearing, to be carried out by the GMC;
		10. She must disclose the Assessors' Report of the assessment of her professional performance to any current and prospective employers (at the time of application) and any other individual involved in her retraining and supervision;
		11. a. She must maintain a log summarising her work on a case by case basis, b. She must provide a copy of this log to the GMC on a three monthly basis;
		12. She must allow the GMC to exchange information with her employer, or any organisation for which she provides medical services, and any individual involved in her supervision;
		13. She must inform the GMC of any formal disciplinary proceedings taken against her, from the date of this determination;
		14. She must inform the GMC if she applies for employment outside the UK;
		15. She must inform the following parties that her registration is subject to the conditions, listed at (1) to (14), above, * Any organisation or person employing or contracting with her to undertake medical work, * Any prospective employer (at the time of application), * Her Regional Director of Public Health.
